**Conduct and Liability:**

I acknowledge the participant youth has signed and agrees to abide by the youth code of conduct while at church events. I acknowledge if the participating youth does not abide by the signed code of conduct, then the guardian or emergency contact will be responsible for picking the youth up from the event. As well, I agree to work with church leadership and the youth in question to come up with an action plan for the adherence to the code of conduct at future events.

I acknowledge the participating youth can be provided transportation by authorized staff members for church events when appropriate. In consideration of the opportunity to participate in the activities held by Immanuel Lutheran Church, I as the guardian of the participating youth accept the risks that may come from participation and transportation to and from any activities.

I acknowledge if the participating youth is injured or requires medical intervention at a church event the staff and volunteers are authorized to contact emergency services and provide interim medical treatment.

I acknowledge participation in activities held by Immanuel Lutheran Church could involve risk to the participant and may result in various types of injury, property damage, and financial damage. As the Guardian, I accept financial responsibility for any injury the youth may sustain as well as any property damage. Further, the participation youth and guardian release and promise to indemnify, and defend, and hold the church, staff, and volunteers harmless for any injury or damage arising directly or indirectly out of the church event. Whether such injury or damage arises out of the negligence of the participant, activity sponsor, or otherwise.

If a dispute over this agreement arises or any claim for the damages arises, I agree to resolve the matter through a mutually acceptable alternative dispute resolution process. If an agreement cannot be reached, I agree upon the submission of the matter to a three-member arbitration panel in accordance with the rules of the American Arbitration Association, for the resolution to the dispute.
